### **Objectives and Investment Policy**

The objective of the Fund is to preserve capital and generate income and capital growth over the long term (5 years and over).

The Fund will aim to meet its investment objective by investing at least 80% in a portfolio of companies incorporated and listed in the UK.

The Fund may also invest in overseas equities, bonds, money market instruments, deposits and cash and near cash.

There will be no particular emphasis on any industrial or economic sector.

If you hold income shares any income from the Fund may be paid out to you.

If you hold accumulation shares, any income from the Fund will be reinvested to grow the value of your investment.

You can buy and sell shares on any business day.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
